I FURTHER ACKNOWLEDGE THAT IT SHALL NOT BE A DEFENSE UNDER SUCH ORDINANCE FOR A VENDOR TO ASSERT OR CLAIM THAT AN EMPLOYEE OR AGENT OF THE VENDOR UNLAWFULLY SOLD OR SERVED ALCOHOL OR BEER TO A MINOR CONTRARY TO THE VENDOR'S RULES, POLICIES, PROCEDURES, OR TRAINING. ASSERTION OF SUCH A DEFENSE WILL NOT PREVENT THE VENDOR'S LICENSE FROM THE PENALTIES SET FORTH IN PARAGRAPH (H) OF THE ORDINANCE.

I FURTHER ACKNOWLEDGE THAT ALCOHOL COMPLIANCE CHECKS ARE PERFORMED ON A REGULAR AND ONGOING BASIS IN THE COMMUNITY BY LAW ENFORCEMENT AND CONSENT TO SUCH COMPLIANCE CHECKS AS A NECESSARY CONDITION OF OBTAINING AND RETAINING A LICENSE FROM THE CITY OF OWASSO.

I FURTHER ACKNOWLEDGE THAT THE ALCOHOL/BEER LICENSE ISSUED BY THE CITY OF OWASSO MAY BE SUSPENDED OR REVOKED BY THE CITY OF OWASSO IF AN OWNER, OFFICER, DIRECTOR, MANAGER, EMPLOYEE, OR AGENT OF THE VENDOR IS EITHER CONVICTED OF SELLING OR SERVING ALCOHOL OR BEER TO A MINOR ON THE VENDOR'S BEHALF OR ENTERS INTO A PLEA BARGAIN AGREEMENT AFTER BEING CHARGED WITH SUCH OFFENSE.
